

# Lenses

## Novice

- Lenses bend light that pass through them, while mirrors bounce light off them.

## Intermediate

- Airy disks are the result of diffraction of light and limit the resolution of any image.
- The path that light travels can be traced as straight lines, except at surfaces between different transparent materials (e.g., air and water, air and glass) where the light path bends.

## Expert

- Different materials refract light by different amounts, governed by Snell's Law and the thin lens equation.
- Use the thin lens equation to build telescopes of different focal lengths.
